24 The above-referenced case on regularly for hearing on February 24, 2010 at 8:30 am in  
25 Department 506 of the Superior Court of California, County of San Francisco. Plaintiff appeared  
26 on his own behalf. No one appeared on behalf of any defendant. The Court notes that Plaintiff  
27 has not filed proofs of service as to any defendant.

28 Plaintiff obtained and served small claims subpoenas (SC-107) on witnesses GoDaddy  
29 Inc., eNom Inc., and NameCheap Inc. requesting the true identities and addresses of the  
30 individual(s) using the domain names at issue to send unsolicited commercial email.

1 The Court finds that Plaintiff's process server effected service of the subpoena on  
2 NameCheap Inc. on January 20, 2010 (more than 30 days before this hearing). See Attachment  
3 1. NameCheap Inc. was served at its claimed business address: 8939 S. Sepulveda Blvd. #110-  
4 732, Los Angeles, CA 90045. See Attachment 2 (a page from NameCheap Inc.'s Privacy  
5 Policy). The Court finds that this address is actually a box at a branch of The UPS Store. See  
6 Attachment 3. The Court finds that service at The UPS Store, a commercial mail receiving  
7 agency, is proper pursuant to Cal. Business & Professions Code § 17538.5(c) and (d).

8 The subpoena to NameCheap Inc. demanded the identity and address of the individual(s)  
9 who registered the domain name [REDACTED] through NameCheap Inc.

10 Plaintiff testified that NameCheap Inc. never mailed a copy of the declaration of  
11 custodian of records to him.

12 NameCheap Inc. has not sent any documents responsive to the subpoena to this Court, in  
13 disregard of the subpoena.

14  
15 IT IS HEREBY ORDERED:

- 16 1. That NameCheap Inc. is in contempt of court due to failure to obey the subpoena.
- 17 2. That NameCheap Inc. is liable to Plaintiff Daniel L. Balsam for the sum of Five Hundred  
18 Dollars (\$500.00) due to its failure to obey the subpoena.
- 19 3. That NameCheap Inc. is additionally liable to Plaintiff Daniel L. Balsam for the sum of  
20 Forty Five Dollars (\$45.00) for cost of service of the subpoena.

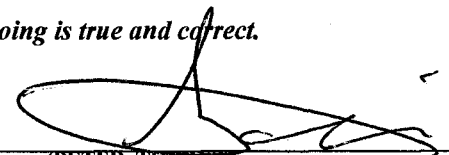
